# From Health Canada:

Consultation for the biomonitoring component of the Canadian Health Measures Survey Health Canada is currently developing scientific content for the biomonitoring component of future cycles of the Canadian Health Measures Survey (CHMS). As a part of this process, we invite you to participate in an electronic consultation (e-consultation) to provide input on which chemicals to include.

The CHMS is an ongoing biennial national health survey that collects data on the general health and lifestyles of Canadians to provide information on chronic and infectious disease, physical fitness, nutrition, and other factors that influence health. In the biomonitoring component of the CHMS, concentrations of about 90 chemicals are measured in blood and urine samples collected from the survey participants. The attached documents provide background information on both the CHMS and the consultation process.
